(His tombstone was erected by his wife, Sarah L. Mansfield. His death certificate is not recorded in the Morgan County Court House. Page 27 of "Atlas Map of Morgan County, Illinois, 1872" shows that he was born in Warren County, Indiana and came to Morgan County, Ill. in 1837.)
