He applied for pension Feb 10 1885, no state listed, assumed to be IL.

In 1900 he was living with his daughter Jennie and her husband, John Rule in Jacksonville. Sarah and children were living in Springfield with or by their son Thomas and family.

He was admitted to the Soldier's Home in Quincy IL on Oct 19, 1905, patient number 7277..

He died Jul 28 1910 as reported by Colonel L. W. Shepherd Post GAR Post 628, Quincy, IL He is listed in the 1956 Illinois Honor Roll as being buried in Jacksonville East Cemetery on Feb 1887. (Incorrect) No stone found.

There is also a Thomas D McLaughlin, no unit or date listed, buried in Sunset Cemetery, old cemetery at the Soldier's home.

His wife, Sarah, applied for pension August 6 1910 from IL.
