They farmed in Nixon Twp, Dewitt Co., IL for several years. Maude, their only child, married Charles Gale and they took over the farm when James retired. James and Catharine then lived with them for the rest of their lives. In 1900 they show an son, Jeffy, age 12 living with them and Mabel(Maude?).. Catharine stated she had 2 children both still living.

He applied for pension May 25 1878 and Feb 18 1907, no state listed, assumed to be IL. His wife, Catherine, applied for pension Mar 6 1933 from IL.

He died Feb 13 1933 at Weldon, DeWitt Co., IL Xxneed burial(Weldon cemetery?)
